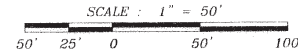

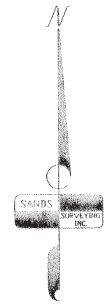

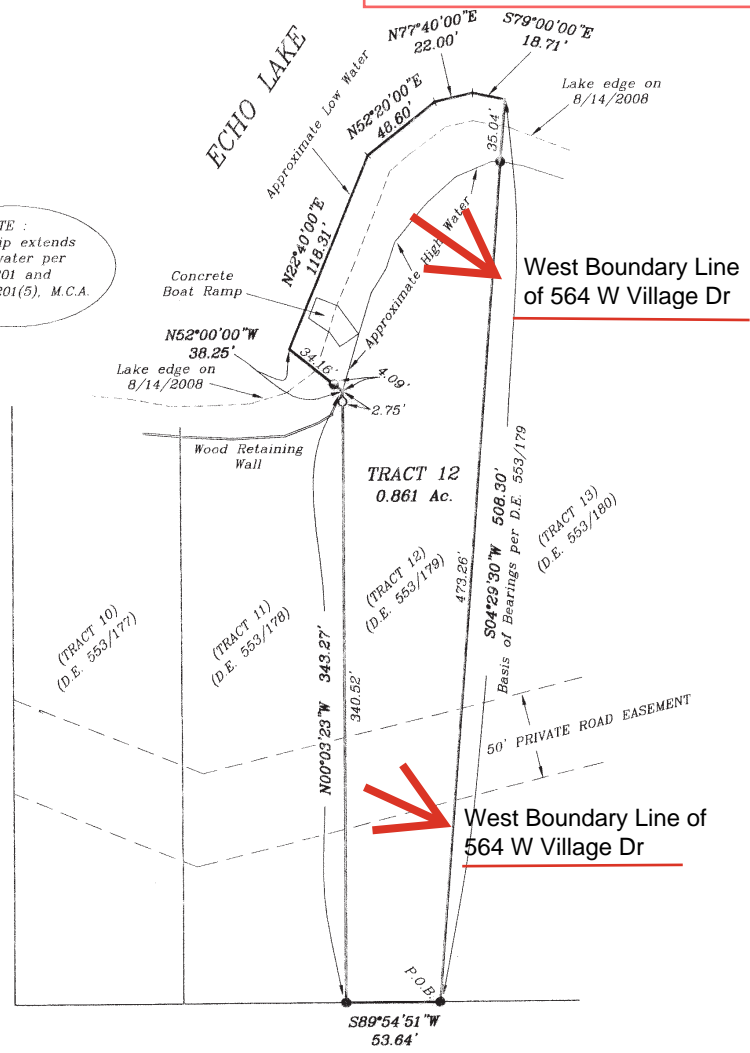


PURPOSE: RETRACEMENT
