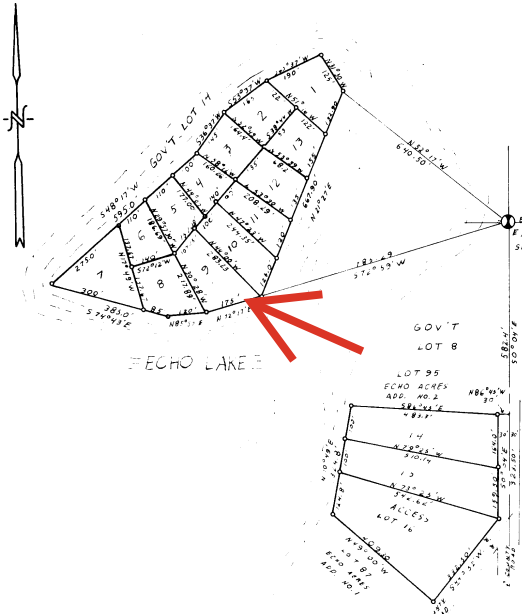


PLAT DEER ISLAND CO.

We, the undersigned property owners, do hereby certify that we have caused to be surveyed, sub-divided and platted into lots and an access lot as shown by this plat and described in this CERTIFICATE OF DEDICATION all of the following described tract of land in Flathead County, Montana to wit:

A tract of land consisting of all of Government Lot Fourteen (14) of Section Eight (8) and a tract of land in Government Lot Eight (8) of Section Eight (8) all in T 27 N - R 19 W, P.M.M., Flathead County, Montana and more particularly described as follows to wit: Commencing at the southeast corner of lot ninety-five (95) of 2000 ACRES ADJUSTED NO. 2 a plat of which is on file and of record in the office of the County Clerk and Recorder of Flathead County, Montana and the true point of beginning of the tract of land being described; thence S 0° 00' E., and along the westerly boundary line of a County Road, 323.50 feet to a point; thence S 86° 50' W., and along the northerly boundary line of a County Road, 120.00 feet to a point on the southwest corner of lot eighty-seven (87) of 2000 ACRES ADJUSTED NO. 1; thence N 80° 00' W., and along the easterly boundary line of said lot 7, 408.3 feet to the northeast corner of lot 87; thence N 80° 00' E., and along the westerly shoreline of 2000 ACRES, 374.4 feet to a point on the southwest corner of lot 95 of Echo Acres Add.
